

**RESOLUTION NO. 2022-05-18**

**A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF TEAGUE, TEXAS, DECLARING THE RESULTS OF THE CANVASS FOR THE ELECTION RETURNS OF THE GENERAL ELECTION OF MAY 7, 2022 FOR THE PURPOSE OF ELECTING MAYOR AND TWO MEMBERS OF THE BOARD OF ALDERMEN, ALDERMAN PLACE I AND ALDERMAN PLACE III, FOR A TERM OF TWO YEARS.**

**WHEREAS**, the Board of Aldermen of the City of Teague, Texas (City) held a General Election on May 7, 2022 for the purpose of electing a three members of the Teague Board of Aldermen for a term of two years; and

**WHEREAS**, a Canvass of the General Election including the returns was conducted on May 17, 2022; and

**WHEREAS**, it was found that the persons herein named received the following votes for said term of office of Teague Board of Aldermen of the City of Teague.

**Mayor**

James Monks	received 157 total votes
David Huffman	received 206 total votes

**Alderman Place I**

Jerry Ballew	received 141 total votes
Garlan Steed	received 213 total votes

**Alderman Place III**

Douglas Allen	received 70 total votes
Lois Ann Mims	received 196 total votes
Marilyn Michaud	received 92 total votes

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF TEAGUE;**

**SECTION 1.** The finds set forth above are incorporated into the body of this Resolution as if fully set forth herein.

**SECTION 2.** **David Huffman** is hereby declared to be elected as Mayor.

**SECTION 3.** **Garlan Steed** is hereby declared to be elected as Alderman Place I.

**SECTION 4.** **Lois Ann Mims** is hereby declared to be elected as Alderman Place III.

**SECTION 5.** The City of Teague hereby finds and determines as result of the Canvass held on May 16, 2022 that combined Election Day and Early Vote totals of **363** votes were cast in the General Election , consisting of **219** Early Votes cast and 144 Election Day votes cast as indicated by the Poll list for the General Election held on May 7, 2022.

**SECTION 6.** It is hereby declared the City of Teague approves and accepts the results of the General Election for the Mayor, Alderman Place I, and Alderman Place III as set forth in the Order attached hereto as Exhibit A, as determined by the majority vote of the qualified voters of the City of Teague.

**SECTION 7.** This Resolution will become effective immediately upon its passage by the Teague Board of Aldermen.
