BOARD OF ALDERMEN REGULAR CALLED MEETING JUNE 17, 2019 6:00 P.M.

- 1. CALL TO ORDER AND ANNOUNCE QUORUM IS PRESENT: The meeting was called to order at 6:00 P.M. by Mayor James Monks and a Quorum was announced with all present Aldermen seated at their respective places.
- 2. INVOCATION: Alderman Nickleberry
- 3. PLEDGE TO THE FLAG: Alderman Mathison
- 4. ROLL CALL: <u>Present</u>: James Monks, Mayor, Jerry Ballew, Mayor Pro Tempore / Alderman Place I, Rhonda Jones, Alderman Place II, Marie Hertenberger, Alderman Place III, Chris Nickleberry, Alderman Place IV and Ryan Mathison, Alderman Place V.

6. CONSENT AGENDA:

Alderman Ballew moved to table Item 6 E, seconded by Alderman Mathison. Motion carried 5-0.

7. OLD BUSINESS:

- a. Accept the financial reports from the City of Fairfield for the TDCJ Operation and Maintenance Fund for the months of June, July, August, September, October, November and December 2018, January, February, March and April 2019.

 **Alderman Ballew moved to table Item 7 A, seconded by Alderman Hertenberger. Motion carried 5-0.
- b. Discussion and possible action on approving the Operating Plan, of the City of Fairfield as outlined in the Interlocal Definitive Agreement, for the TDCJ Boyd Unit Water and Wastewater Facilities. *Alderman Ballew moved to table Item 7 B, seconded by Alderman Hertenberger. Motion carried* 5-0.

8. **NEW BUSINESS:**

a. Receive information and request for a civil engineer study or comparable from Karl Drake Paris regarding the drainage in the Parkwood Subdivision.

Mr. Paris presented video and information regarding the flooding on Don Juan Street and his shop located next to his house at 210 Don Juan Street. He expressed his frustrations and that he felt that the recent ditch work completed by the Public Works Department was not sufficient to fix the problem. He requested that the City employ a civil engineer to address the issue.

Minutes June 17, 2019:

Alderman Ballew moved to acknowledge the request for a civil engineer study or comparable from Karl Drake Paris regarding the drainage in the Parkwood Subdivision, seconded by Alderman Mathison. Motion carried 5-0.

b. Conduct a Public Hearing for the purpose of receiving citizens input regarding the 1991 white Ford motorhome, located at 312 South 9th Avenue Teague, Texas, 75860, being a public nuisance.

Public Hearing Opened at 6:28 P.M.

Police Chief Philpott presented information regarding the state of the vehicle and the procedures his department has completed regarding declaring the vehicle a nuisance.

Public Hearing Closed 6:31 P.M.

c. Discussion and possible action on entering a finding regarding the public nuisance status of the 1991 white Ford motorhome, located at 312 South 9th Avenue and approving Resolution 2019-06-20-2.

Alderman Ballew moved to enter finding and approve Resolution 2019-06-20-2, seconded by Alderman Mathison. Motion carried 5-0.

d. Discussion and possible action on approving the Teague Economic Development Corporation's board approved request to lower the amount of the awarded Façade Grant to Joy Bowers – Linda Buchanan Properties at 518 Main Street, that was approved by the Board of Aldermen at the February 19, 2019 Meeting from \$5,220 to \$4,950.

Stephanie Burns, EDC President, stated that there were changes made to their plans lowering the amount to be expended.

Motion to approve Item 8 D as written was made by Alderman Nickleberry, seconded by Alderman Jones. Motion carried 5-0.

e. Discussion and possible action on approving the Teague Economic Development Corporation's board approved request to purchase 15.796 acres located on West U.S. Highway 84, Parcel ID 2518, in the amount of \$129,000; funds to be appropriated from redistributing Fiscal Year 2019 approved budgeted line items, Old City Hall in the amount of \$84,000 and Office Furniture/Décor in the amount of \$45,000. Stephanie Burns, EDC President, stated that the EDC has the opportunity to purchase the property adjacent to the 4-acres they currently own on Highway 84 for \$120,000.

Alderman Ballew asked, will this have railroad access?

Mrs. Burns replied, ves.

Alderman Nickleberry asked, are there any plans for this property?

Mrs. Burns replied, there are some in the works.

Alderman Ballew made a motion to approve the Teague Economic Development Corporation's board approved request to purchase 15.796 acres located on West U.S. Highway 84, Parcel ID 2518, in the amount of \$120,000; funds to be appropriated from redistributing Fiscal Year 2019 approved budgeted line items, Old City Hall in the amount of \$80,000 and Office Furniture/Décor in the amount of \$40,000, seconded by Alderman Mathison. Motion carried 5-0.

f. Discussion and possible action on approving the proposal to convert the City's operating software to FundView.

City Administrator Prasil presented FundView's proposals.

Alderman Ballew moved to approve converting the City's operating software to FundView to include Code Enforcement and Permits, seconded by Alderman Hertenberger. Motion carried 5-0.



g. Discussion and possible action on approving Resolution 2019-06-17 authorizing the City to enter into an Interlocal Agreement with the cities of Groesbeck, Mexia, Thornton, Kosse, Coolidge, and Wortham, pursuant to Section 362.002 of the Texas Local Government Code to form a mutual aid law enforcement task force in order to cooperate in criminal investigation and other law enforcement activities; and authorize the Mayor to execute the Mutual Aid Law Enforcement Agreement. City Administrator Prasil requested that this item be tabled.

Alderman Ballew moved to table Item 8 G, seconded by Alderman Mathison. Motion carried 5-0.

h. Discussion and possible action on approving Bureau Veritas' amendment to Attachment B Fee Schedule for inspections, in compliance with 2019 Texas Legislative Action, HB 852.

Motion to approve Item 8 H as written was made by Alderman Nickleberry, seconded by Alderman Ballew. Motion carried 5-0.
