- **Speeding in School Zone:** Add \$100
- **Disregard Stop sign:** \$190
- **Disregard Traffic Control Device:** \$284
- **Invalid or Expired Registration:** \$165  
(Can dismiss for \$20 fee if remedied within 20 days of the citation & if expired less than 60 days.)
- **Expired Inspection:** \$184  
(Can dismiss for \$10 fee if remedied within 20 days of the citation)
- **No Insurance/ Failed to Maintain Financial Responsibility:** \$385  
(Dismissed without a fee if evidence of valid insurance at the time of the citation is presented to the court and the court is able to verify coverage.)
- **NO DL:** \$185
- **Failure to Update DL:** \$131  
(Can dismiss for \$20 fee if remedied within 20 days of the citation)
- **Expired DL:** \$165  
(Can dismiss for \$20 fee if remedied within 20 days of the citation)
- **Failure to display DL:** \$181  
(Can dismiss for \$20 fee if remedied within 20 days of the citation)

## Past Due / Show Cause Hearings:

If you do not comply with the terms of your driver's safety course, deferred disposition, or payment plan:

- A one-time \$15 payment plan fee is added
- A show cause letter is mailed (Defendant is required to keep the court up to date on their current mailing address)

If you do not appear for your show cause, a conviction is entered and warrants, along with warrant fees, will be issued.



### Court Dress Code

Proper Dress code is required in the courtroom. The court reserves the right to refuse to hear any case from those who fail to abide by the dress code. Proper attire does **NOT** include hats, caps, bandanas, bare feet, flip flops, revealing clothing, ripped or torn clothing, heavily soiled clothing, obscene clothing, or visible undergarments.

Must appear in open court before the judge with a parent or legal guardian.  
The judge CANNOT speak to a minor without a parent or legal guardian.

**DEFERRED DISPOSITION**  
(CDL holders are not eligible)

**Eligible If:**

- Hold a valid driver's license
- Not currently on deferred disposition status
- Speed was less than 25 mph over the speed limit or you were not travelling more than 95 mph.

**\*\*If you are a Texas Driver's License holder and under the age of 25, you are required to complete a Texas approved driver's safety course during the 90-deferral period.\*\***

You pay the fine amount (the cost of the ticket plus \$100). If you do not receive another ticket from a TPD officer in the following 90 days, the ticket will be dismissed and will not report to your driving record.

**Need to change your Court Date?**

If you are unable to appear in court on your scheduled date and time, please send a written request for the next scheduled court date. To be approved, your written request must include the date you are requesting to come to, court, your citation number, and postpone your date ONE time to the next available court date.

**DRIVER SAFETY COURSE**  
(CDL holders are not eligible)

**Eligible If:**

- 17 years of age or older
- Offense was a moving violation
- Have a valid TEXAS Driver's License, or active-duty military ID (out of state licenses are not eligible)
- Speed was less than 25 mph over the speed limit, or you were not traveling 95 mph or greater
- Have not taken a state approved driver safety course in the past 12 months; and

**HAVE NOT COMMITTED ANY OF THE FOLLOWING**

- Failing to give information at an accident scene;
- Leaving the scene of an accident;
- Passing a school bus;
- Offense occurred while driving a commercial vehicle;
- Offense occurred in a construction zone where workers were present.
